Protected Against "All Risk"

Your cargo is protected against "All Risk" of physical loss or damage from any external cause irrespective of percentage of loss.



From Warehouse to Warehouse

Coverage commences from the time goods leave the shipper and/or supplier's place of business and continues in force during the ordinary and customary course of transit to the final destination.

Insurance remains in force for fifteen days after vessel discharge or upon delivery, whichever occurs first. Concealed damage must be reported within three business days of delivery.



No Deductible

In the event of a loss, Seven Seas assumes 100% of the risk so you won't have to meet a deductible before your claim is settled.

Proper packaging is a condition of insurance.

Specific terms and conditions may vary per type of cargo. Coverage is not available for certain commodities.

- In the event of a loss, notify the ocean carrier or your transportation company.
- To ensure no delays in the processing of your claim, please provide relevant information to support your loss.
- Our accredited claims adjustors act promptly to resolve claims.
- Prompt notification for concealed damages is required. Concealed damage must be reported within three (3) business days of delivery.

Note: Damaged goods must be retained for presentation at time of settlement.
